It must be admitted that the intention of the testator here was, not to die intestate as to any part of his property. His object was to provide for all his family, and meet their necessities and wants. Independently of the words, this intention on the part of the testator may be gathered from the trusts and uses for which he devised to the plaintiffs, anil which evidently shew that it was his meaning, that the freehold estate in question should be sold. The authorities prove that the word estate, if there be nothing to controul it, will of itself carry the fee. In Tirrel v. Page (1), a devise of divers legacies in money, and then followed a devise of lands--"all the rest and residue of my money, goods, and chattels, and other eitalt whatsoever, I give ...
